1. Check with Department of Agriculture and Water Resources (or relevant authority if not importing into Australia) which tests are required for your pet.

2. Determine which tests AAHL can perform. Information is available at our Laboratory Services site, or you can contact us on +61 3 5227 5414 or aahl-accessions@csiro.au.

3. Organise for samples to be collected by a registered Veterinary Surgeon.

4. Check that samples are correctly labelled and that they match accompanying paperwork. Please ensure that labels recording the microchip number on the tubes are written with a permanent ink pen. **This is important – errors can lead to delays.**

5. Obtain a Health Certificate from the Veterinary Surgeon who took the samples. Information on what to include in this certificate can be found in section B4 below.

6. Check that your Veterinary Surgeon packaged the samples in a transport container that conforms with IATA Packaging Instruction #650.

- 7. Enclose inside the box:
 - a) The Import Permit for the samples
 - **b)** A Specimen Advice Note (SAN), either completed online at our Laboratory Services site, or by filling in the form manually.
 - c) A completed Payment Form.

8. Enclose these forms in the document envelope on the outside of the package:

- a) The Import Permit for the samples
- b) The Health Certificate (see 5.)
- c) A completed Specimen Advice Note (SAN)
- 9. Address your samples to:

10. Check that the Courier records 'free domicile' on the Consignment note (this means that all costs are the responsibility of the sender.)

11. Email a copy of the consignment note to <u>aahl-accessions@csiro.au</u> if the submission has not been lodged online.

12. Pay for your tests. Results will not be released until payment is received. Payment must be made by credit card unless other arrangements have been made.
